Another mandatory wood-burning ban in fireplaces and in all indoor and outdoor devices was again in effect over the weekend due to increased air pollution, at least some of which is caused by food ending up in landfills, producing methane gas. On November 30 our air quality was again rated "unhealthy," which is worse than the usual "poor" air we breathe. Food in landfills "causes significant air pollution" by emitting methane, a greenhouse gas "84 times more potent than CO2 over 20 years." As the food decomposes it also produces other harmful pollutants (PM2.5), contributing to climate change and poor air quality, and "can worsen asthma and other health conditions." About half of what Californians landfill is organic waste, with "food scraps being a major component," around 20-22%.

Reduced methane emissions, healthier communities and economic resilience are some of the "long-term, measurable outcomes" of work being done by Abound Food Care, originally known as Waste Not OC. In 2017 the WNOC model was "recognized as the nation's most effective food recovery program." Abound and a network of other nonprofits are "rescuing food direct from growers, processors, and retailers." Their efforts have resulted in more than 92 million pounds of food recovered, producing 77 million meals, and reducing pollution equivalent to taking 3,000 cars off the roads every year.

Even with all of their efforts, Abound's CEO noted that "30 to 40 percent of all food produced in the U.S. is wasted, and the cost of this waste exceeds all federal nutrition program budgets combined." He pointed out that "eliminating food waste, ending food insecurity, and slowing climate change don't have to be separate goals." His plan for "systemic changes" are aimed to address issues such as volunteers using personal vehicles to transport surplus food, "negatively impacting any environmental benefits associated with reducing food waste." Proposed changes include coordinating logistics such as transportation, and using solar-powered cold storage.

This correction addresses a verbal statement made during the meeting by Mayor Slater: "The OPA Association Board is in favor of the MOU."

#### This statement is inaccurate:

- 1. The Orange Park Association's official statement, documented in the letter submitted on July 21, 2025, stated that the Orange Park Association "understands that the MOU could be a useful roadmap." Please see attached letter
- 2. The Orange Park Association is not in favor, approving, or agreeing to any terms and conditions outlined in the MOU. The Orange Park Association only supports the *process* of using an MOU, but not the specific terms at this time.

We respectfully request that this clarification letter and attachment be formally filed in Public Comments and attached to the meeting minutes for the December 9, 2025 City Council meeting referencing the City Council Meeting held on Tuesday, July 22, 2025, concerning Agenda Item 3.9 (MOU between the City of Orange and Milan REI X, LLC), to ensure the public record accurately reflects the Orange Park Association's position.
