

RESOLUTION NO. 11569

**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF ORANGE AUTHORIZING THE
APPLICATION FOR FEDERAL FINANCIAL
ASSISTANCE GRANT FUNDING WITH THE
CALIFORNIA GOVERNOR'S OFFICE OF
EMERGENCY SERVICES FOR THE
PURPOSE OF OBTAINING FEDERAL
FINANCIAL ASSISTANCE FOR ANY
EXISTING OR FUTURE GRANT PROGRAM**

WHEREAS, on April 11, 2024, the California Office of Emergency Services was notified by the Federal Emergency Management Agency, that the City of Orange had received approval for Hazard Mitigation Grant Program funds.

WHEREAS, the total project cost is \$199,999.00 and consists of a 75% Federal share of \$149,999.25 and an obligated 25% non-Federal share of \$49,999.75

WHEREAS, the Federal Emergency Management Agency is also obligating and providing a 100% Federal share Subrecipient Management cost of \$9,991.50

WHEREAS, the City of Orange will develop and adopt a Federal Emergency Management Agency approved Hazard Mitigation Plan to meet the requirements outlined in 44 CFR Part 201 and the most current Federal Emergency Management Agency hazard mitigation guide.

WHEREAS, the project will take 36 months to complete with a completion date set for April 5, 2027, and within 120 days of its conclusion, all project funds will be liquidated with final closeout documentation submitted to the Federal Emergency Management Agency.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Orange, with acknowledgement of the Orange City Fire Department,

1. Is a public entity established under the laws of the State of California and is authorized to file applications with the California Governor's Office of Emergency Services for the purpose of obtaining federal financial assistance for any existing or future grant programs.
2. Authorizes its City Manager and designated agents, to provide the Governor's Office of Emergency Services for all matters pertaining to such state disaster assistance the assurances and agreements required.
