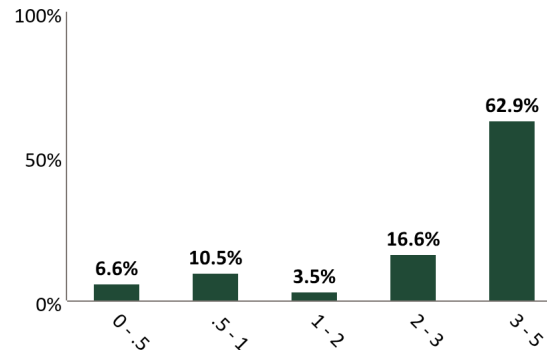

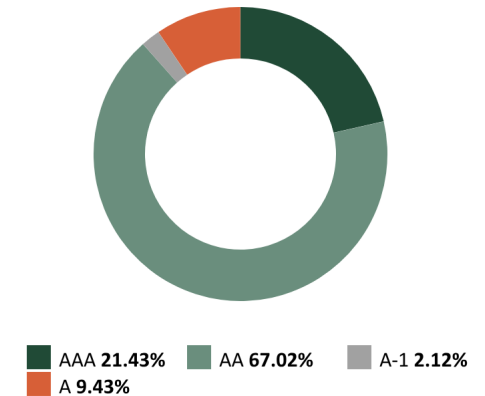
Maturity Distribution
