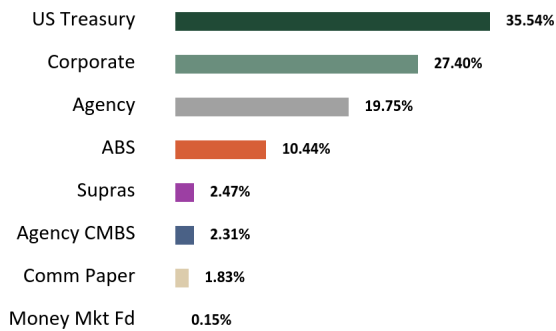

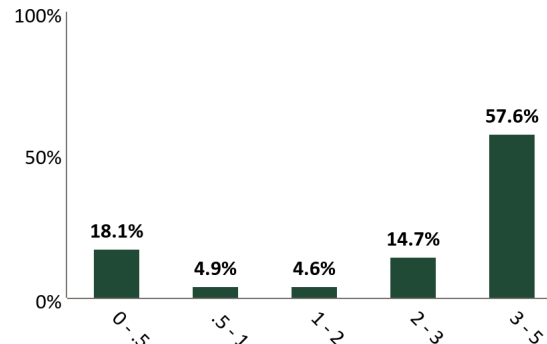
Sector Allocation

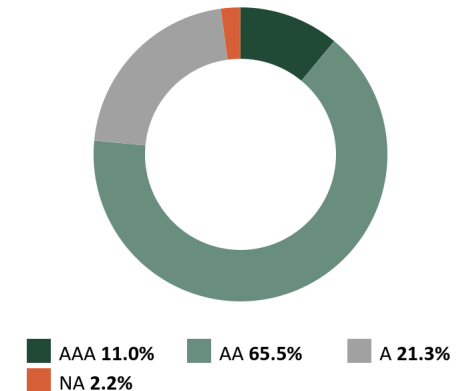
Maturity Distribution
