Everybody talks about the weather, but nobody does anything about it is an old saying defied for many years by individuals and organizations taking action to create cooler and cleaner air by reducing greenhouse gases from appliances, vehicles and landfills. The City can help by educating residents and businesses and providing them with support to keep food scraps and other organic waste from landfills, where it produces methane emissions creating air pollution and hot temperatures.

The City of Tustin applied for and received funding to hire a consultant for implementing SB 1383, the State's organic waste recycling mandate. Tustin was "actually ahead of most cities in Orange County" in complying with the September 2024 deadline in having CR&R distribute organic waste recycling carts, including to all 275 multi-family dwellings. Negotiating new or amended contracts with waste haulers such as CR&R to implement the mandate caused many cities "to be a year behind" Tustin.

EcoNomics Inc. is the environmental consulting firm Tustin retained to oversee and monitor CR&R and its accounts to ensure contract performance standards are met, including for the food scrap recycling program. EcoNomics also provides outreach and education to residents and businesses through social media, videos and brochures, and multilingual recycling training. In a video collaboration with Tustin, EcoNomics shares tips and tricks for setting up and maintaining a vermicomposting bin at home, an alternative to putting food scraps in organic waste carts.

For the City of Mission Viejo, another municipal client, EcoNomics created and posted on its website a video of managers from an apartment complex, a restaurant and a deli, and also a church leader, sharing the benefits of using food waste carts from Waste Management, the contracted waste hauler. Orange may not have a paid consultant to perform those services, but there is no shortage of talent willing to volunteer. The City could reach out to Chapman University, which provided a sustainability plan last year, to create similar videos to be posted on the City's website, social media and government channel. Such videos could be presented at meetings of various organizations, including the Chamber of Commerce and non-profits.

I am writing as a deeply concerned resident of the City of Orange to express my strong opposition to two items on tomorrow's agenda:

- 1. Proclamation Recognizing September 15-October 15 as National Hispanic Heritage Month
  - While I deeply value and celebrate Hispanic heritage, this proclamation feels hollow and performative when our communities are simultaneously being torn apart by immigration raids and federal enforcement actions. It is deeply disheartening to see the City issue proclamations celebrating culture and diversity while failing to take a stand for immigrant families living in fear and facing separation. Words of recognition ring empty if not backed by policies and actions that actually protect and uplift the very people being honored. Our city should be working to create a safe and supportive environment for all residents, especially those most vulnerable, not issuing symbolic statements disconnected from their lived realities.
- 2. Item 5.1: Resolution Opposing Proposition 50 (Bilodeau)

To the Honorable Mayor & Members of the City Council,

I am writing this out of an abundance of concern for the agenda item being proposed and discussed this evening, September 9<sup>th</sup>. My son plays for a youth recreational baseball league at Olive Pony. Having played baseball as a youth for South Sunrise, I can speak to the resilience, teamwork, and discipline that was instilled in me and is now being instilled in my son. The proposed cost increase of 850% for the hourly rate for our non-profit youth organization will ostracize and inevitably have a detrimental impact on dozens of youths within our league, and hundreds, if not thousands more in the not-so-distant future.

My hope is that the Mayor and your Council will reevaluate the independent study that was performed by Matrix Consulting Group and find a different avenue of revenue stream that does not include creating barriers to entry for youth in sports. As a manager of a business, I can appreciate the need for reducing costs while trying to simultaneously add revenues, especially in today's economic climate. That being said, Olive Pony and other not for profit youth leagues that operate in the City of Orange should have to bear the brunt of these increases that are being enacted to counteract a budget deficit. These programs have an incredible impact on the psychosocial development of our youth that improve their mental health while also creating a safe and healthy environment for them to build camaraderie and friendships.

Many of our youth leagues are volunteer ran, including Olive Pony, which allows for our facilities to be interdependent on the efforts of parent and family members to ensure the fields are kept in good repair and the local facilities within the parks need not be maintained by City employees to a greater degree. At Olive Park, our league has also contributed through capital improvements such as fencing, scoreboards, storage solutions, and even turf projects.

I feel I can speak for most parents within the non-profit youth sports organizations that take place in the beautiful City of Orange when I say our programs are being unfairly targeted when other services are being adjusted more moderately. Important to note as well that the sheer volume of hours we utilize the facility, which is year-round, allows for a constant monitoring and abates much vandalism, damage, and unsafe conditions that many cities within Orange County face.

I hope that serious considerations will be made to protect our youth's right to these same community services that have been offered for generations and the City will not institute economic barriers that would either encumber or all but eliminate families from being able to participate in these vital services that our organizations offer. In summation, please vote NO on Agenda item 9.3 in its current form and initiate a broader discussion with community stakeholders before any fee schedule is finalized.







Councilman Bilodeau's statement argues that Prop. 50, "undermines the voter-approved framework for fair redistricting in California." This statement flies in the face of several of the core components of the proposition. First, this redistricting, which is only being put forward in response to the gerrymandering done in Texas at the behest of the president and without the vote of the people, is a temporary measure which will be handed back to the Citizens Redistricting Commission in 2031. Second, included in the language of a bill is an amendment to the California State Constitution which declares, " "It is the policy of the State of California to support the use of fair, independent, and nonpartisan redistricting commissions nationwide. The people of the State of California call on the Congress of the United States to pass federal legislation and propose an amendment of the United States Constitution to require the use of fair, independent, and nonpartisan redistricting commissions nationwide." This statement not only supports the Citizens Redistricting Commission that Councilman Bilodeau claims that Prop. 50 seeks to undermine, but calls for states throughout the nation to adopt the same commissions, thereby expanding independent districting. Third, by nature of the matter of redistricting being put to the electorate in the form of a ballot proposition, the state of California has, indeed, not undermined the voters.

Councilman Bilodeau also states many times the threat of Proposition 50 "dividing communities" or "forcing some cities and counties to be split among multiple congressional districts under the measure's new maps and diminishing their voice in Congress." Setting aside how Texas has done this exact thing without any input from the electorate, and states like Missouri are seeking to attempt this same maneuver, Councilman Bilodeau's statement seems to ignore the realities of the current congressional district maps. For example, Councilman Bilodeau represents the City of Orange's Fourth District, which sits in both California's 40th and 46th Congressional District. The City of Orange itself is bisected by CA 40 and 46, while neighboring cities of Anaheim and Fullerton also lie in two separate districts. There also exist districts that span multiple counties. California's 40th District, in the current map, spans across parts of Orange, Riverside, and San Bernardino Counties. California's 49th District reaches from Laguna Nigel to well past Del Mar in San Diego County. It is hard to argue that the current maps "keep cities counties, and local communities together," as Councilman Bilodeau's statement claims, when a map and a decent fact check can clearly show otherwise.

Why must the city use time and resources to adopt an official position on Proposition 50 at all? This emotionally charged, intentionally misleading representation of this proposition (a decision for the electorate to make, not this council) appears to be nothing more than grandstanding for far-right ideologues at the federal level at the expense of a city that needs your attention desperately.





When I heard about tonight's proposed fee increase from \$2 to \$19 per hour, I honestly couldn't believe it. A 950% increase? That's not just steep—it's completely unrealistic for families in the area.

My son is now 9 and baseball isn't just a hobby for him—it's been a huge part of his childhood and development. Through Little League, he's learned teamwork, discipline, and perseverance. He's made lifelong friendships and stayed active instead of spending all his time on screens. These are the kinds of experiences every kid in Orange

should have access to, regardless of their family's income.

But here's what really bothers me about this proposal: South Sunrise already spends over \$40,000 a year maintaining these fields. As parents, we volunteer our weekends to help with upkeep, we fundraise, and we do everything we can to keep costs low. Now you want us to pay nearly \$20 an hour to rent fields that we're already maintaining ourselves? That doesn't seem right.

I get that the city has financial pressures—we all do. But putting the burden on kids' sports programs feels like the wrong approach. When registration fees inevitably skyrocket because of this increase, a lot of families in our community simply won't be able to afford it anymore. We'll lose kids who love this game, and honestly, we'll probably lose families who decide Orange isn't the family-friendly community they thought it was.

My son has grown up on those fields at McPherson Park. He's learned to slide into home, caught his first fly ball, and celebrated wins with his teammates there. South Sunrise Little League has been part of Orange for 60 years—longer than most of us have lived here. It would be heartbreaking to see that tradition end because the city decided to price out the very families these programs serve.

I'm asking you to please vote no on this increase. Our kids deserve better than being treated like a revenue source. They deserve the chance to play ball without their parents having to choose between baseball and other bills.

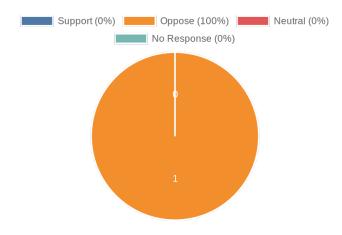
