"It's a great idea," states Chapman University's Fred Smoller, a leader in promoting sustainable solutions to climate change, citing eight new clean energy school buses that have begun transporting students in the Anaheim Elementary School District. Studies show that one electric school bus on the road could eliminate 23 tons of greenhouse gas emissions each year. The buses are funded by the California Energy Commission's School Bus Replacement Program which aims to replace diesel-powered buses with clean energy electric ones to help the state reach its climate goals, meet clean air standards and reduce reliance on fossil fuels. Diesel-powered buses are not safe for children's developing lungs, which are particularly vulnerable to harmful air pollution.

Smoller recently helped obtain a \$5 million grant to organize the Orange County Sustainability Decathlon in 2023 for college students to design and build replicable housing units to accelerate sustainable development throughout the state and country. "We know for certain climate change is real. Just look around at the wildfires, the water shortages and the extreme weather events," said Smoller, an associate political science professor.

Climate change needs to be addressed now, it can't wait for the COVID-19 pandemic to end, is the recent warning to world leaders by more than 230 medical journals in a first-ever joint statement. They declared a 1.5-degree-Celsius rise in global temperatures the "greatest threat to global public health." The world is on track to warm by around 3 degrees Celsius above preindustrial levels by 2100, which would be impossible to reverse. There is no "safe" rise in temperature. The more than 600 people who died in the Pacific Northwest during this summer's record-breaking heat would have been "virtually impossible without climate change," according to climate scientists.

As members of the Orange City Council, you can do more than meet the state's requirements to reduce greenhouse gas emissions. Go beyond your targets and commit to more resilience and extreme weather preparedness to help stop the warming trend that can soon become irreversible.

eComment: Opposition to File #21-0444 Kornerstone Cemetery 2205 E. Palmyra Avenue My family and I live and own a home in the College Park neighborhood just south of the proposed location of the Kornerstone Cemetery (File #21-0444), and I need to officially state my opposition to this project. Our neighborhood is very small, guiet, and safe, and I fear that a 3,360 occupancy cemetery would jeopardize the most desirable traits of the neighborhood. My primary concern is the amount of traffic the cemetery would generate; there are only two small entry streets into our neighborhood of only 120 homes, Palmyra Avenue and E. Karan Lane, through which all traffic to and from the cemetery would travel. According to City documents, normal hours of operation are 8am - 5pm seven days a week, but also delivery of the deceased could occur "sometime during the hours of 5pm to 8am" - meaning that cemetery traffic may occur anytime 24 hours a day, seven days a week. Even though the project provides 51 parking stalls estimated services 25 times a month, the visiting of up to 3,360 families throughout the year, with obligatory "visitation for prayers" increasing during certain times of the year could turn our neighborhood into a continual stream of vehicles and a gigantic parking lot. The community will also be subject to construction traffic & noise for the first year, and I understand from the documentation that excavation equipment will frequently be digging new graves over the next 20 years, creating more noise & construction traffic. This is a huge burden to place upon a small neighborhood. The immediately adjacent homes will be further impacted by the traffic passing in front of their windows & driveways and their views would now be either blocked by high walls or very stark white stone gravesites which, from the sample photos, are very glaring, sparse, and very unattractive. The property is currently zoned as "Recreation Open Space" and the General Plan categorizes it as "Open Space Park" and "Low Density Residential". The property was given to the City by the Yorba family for recreational/children's use - neither of which is satisfied by this project. Modification to both zoning regulations and the General Plan would create a negative impact on the community and deny the intent of the Yorba family. Many of the lives affected by this organization share a common sense of passion and appreciation for Mary's Kitchen. Without a set plan to alleviate the sudden removal of Mary's Kitchen and its decades-long positive impact on the City of Orange, the homeless community that this organization has served for so long will be subsequently abandoned and left with no immediate alternative following the proposed shutdown. This will have lasting impacts on the community, as the homeless population will disperse across the city in search of resources that can attempt to fill the void that the sudden removal of Mary's Kitchen will leave. In turn, the homelessness crisis will further expand across the city and the distribution of city resources to alleviate this issue will be that much more difficult to enact.

The homelessness crisis affects all of Orange County, and I acknowledge the efforts by individual cities to provide support services to individuals experiencing homelessness. I strongly encourage the Orange City Council to reconsider the removal of this decades-long non-profit organization which has been an integral part of the community for so long.

- The provision of basic human needs (healthy meals) has been their primary mission for over 30 years, and Mary's Kitchen has grown to do so much more by providing showers, laundry facilities, clothing and a mailing address; including, being a destination for mobile health, dental and eye clinics that serve the guests regularly. Additionally, local homeless outreach teams are on-site weekly, including mental health services. Many of those served at Mary's Kitchen are seniors and disabled people awaiting housing assistance through the county government.
- We ask that the City Council does not turn its back on Mary's Kitchen and throws the most vulnerable in our community on the street with no access to food. This is simply inhumane. The decision to close Mary's Kitchen will, in fact, force the unhoused community to look for a non-existent replacement of Mary's Kitchen throughout the city and neighboring cities in search for food and services.

Dear Mayor Murphy and City Council Members:

Thank you for your time. I am a provider of legal services to survivors of domestic violence in the City of Orange. Mary's Kitchen has provided sorely needed humanitarian resources to many of my clients over the years, and their services have become even more imperative during the pandemic. For the safety of my clients and other residents of Orange, I hope the city will come together with advocates and providers to ensure that Mary's Kitchen can continue to provide its life-saving services.

The Bette & Wylie Aitken Family Protection Clinic provides legal assistance to low-income survivors of domestic violence, sexual assault and related crimes. Many of our clients are living in their cars, in temporary shelters, or struggle to find a safe place to sleep at night. Many go without meals and worry about how they will feed their children. They need a mailing address to ensure their presence at critical court hearings, clothing for job interviews, and an array of social services for themselves and their children. All of this is currently provided by Mary's Kitchen. No social service is perfect, but Mary's Kitchen is the one homeless service provider about which I have never heard a complaint.

In early 2018, our Clinic founded the Homelessness/Domestic Violence Survivor Task Force of the Orange County Family Violence Council in an effort to better serve the growing number of domestic violence and sexual assault survivors who have been rendered homeless by intimate violence or who have been assaulted while unhoused. Per Orange County data, 40% of unhoused women are domestic violence survivors – many homeless as a direct result of the domestic violence. In 2020, my students and I bore witness as yet more of our clients lost their housing. Many of our clients are older, traumatized, and alone on the street. Others are mothers looking for a safe place to find resources as they parent or work to reunify with their children. When these women speak about Mary's Kitchen, they speak about the comfort, the nourishment, the physical safety, and the emotional stability that it has provided to them. It is their trusted lifeline.

The closure of Mary's Kitchen would bring an end to the sorely needed humanitarian support they provide, resulting in increased levels of trauma, hunger, and homelessness in our community. My clinic and I would love to be of any assistance as the City moves forward with this issue; I'm sure we can put our collective heads together to reach a solution that serves the city's best interest.
