THIRD AMENDMENT

TO

MASTER SUBSCRIPTION AGREEMENT

THIS THIRD AMENDMENT TO MASTER SUBSCRIPTION AGREEMENT (the "Third Amendment") is made and entered into as of ________, 2021, by and between the CITY OF ORANGE, a municipal corporation ("Customer"), and GRANICUS, LLC, a Minnesota Limited Liability Company ("Granicus"), with reference to the following:

- A. Customer and Granicus entered into a Master Subscription Agreement (Agreement No. 6858) dated October 8, 2019, which is incorporated herein by this reference (the "Original Agreement"); and
- B. Customer and Granicus amended the Original Agreement to revise the Scope of Services and increase the compensation by a First Amendment to Master Subscription Agreement (Agreement No. 6858.1) dated July 13, 2020, which is incorporated herein by this reference (the "First Amendment"); and
- C. Customer and Granicus amended the First Amendment to add a Scope of Work, revise the Term and increase the compensation by a Second Amendment to Master Subscription Agreement (Agreement No. 6858.2) dated September 23, 2020, which is incorporated herein by this reference (the "Second Amendment"); and
- D. Customer and Granicus desire to further amend the Original Agreement to modify, amend and supplement certain portions of the Original Agreement to revise the Statement of Work to include host compliance services.

NOW, THEREFORE, the parties hereby agree as follows:

- <u>Section 1.</u> <u>**Defined Terms**</u>. Except as otherwise defined herein, all capitalized terms used herein shall have the meanings set forth for such terms in the Original Agreement.
- <u>Section 2.</u> <u>Cross-References</u>. Customer and Granicus agree that all references in this Third Amendment are deemed and construed to refer to the Original Agreement, as amended and as implemented by this Third Amendment.
- <u>Section 3.</u> <u>Revised Statement of Work.</u> The Statement of Work, <u>Exhibit A</u> of the Original Agreement, as amended, is hereby amended, modified and supplemented to include the services described on <u>Exhibit A</u> attached hereto and incorporated herein by this reference.
- <u>Section 4.</u> <u>**Revised Compensation**</u>. The Compensation payable to Granicus is hereby increased by FIFTEEN THOUSAND EIGHT HUNDRED FORTY-FIVE DOLLARS and 42/100 (\$15,845.42), as detailed in <u>Exhibit A</u> to this Third Amendment.

Section 5. <u>Integration</u>. This Third Amendment amends, as set forth herein, the Original Agreement and, except as specifically amended hereby, the Original Agreement, as amended, shall remain in full force and effect. To the extent that there is any conflict or inconsistency between the terms and provisions of this Third Amendment and the terms and provisions of the Original Agreement as amended, the terms and provisions of this Third Amendment shall control and govern the rights and obligations of the parties.
