A Resolution of the Planning Commission of the City of Orange approving Major Site Plan Review No. 1062-21, Design Review No. 5050-21, and Environmental Review No. 1879-21 Children's Hospital of Orange County (CHOC) with the following additional condition:

The Applicant shall be responsible for managing on-site circulation such that inbound vehicles are not impeded to the extent that would cause encroachment (queuing) onto public streets. In addition, applicant shall be responsible to implement the related three-step plan delineated on the Exhibit submitted by CHOC dated June 29, 2022, and pertaining to parking garage access. City may at any time, based on its observation and at its sole discretion, direct Applicant to implement Step 3 (on-site signing and striping modifications) to the satisfaction of the Public Works Department.
