

RESOLUTION NO. 11702

**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF ORANGE ADOPTING SAID
CITY'S BUDGET FOR THE FISCAL YEAR 2026-
27 AND AUTHORIZING TRANSFER OF FUNDS
WITHIN AND BETWEEN APPROPRIATIONS,
TRANSFER OF FUNDS BETWEEN FUNDS, AND
ADDITIONAL APPROPRIATIONS.**

BE IT RESOLVED by the City Council of the City of Orange, California, as follows:

SECTION I. Adoption of Budget

The City of Orange budget for the Fiscal Year 2026-27, as amended by the City Council and on file in the office of the City Clerk, is hereby adopted as the budget for the City of Orange for the Fiscal Year 2026-27. Appropriations for the Annual Budget are set forth in the Schedule of Operating Expenditures by Fund. Appropriations existing as of June 30, 2026, for CIP projects will be carried over to the 2026-27 fiscal year except for those projects which are completed, as determined by the City Manager, before the end of the 2025-26 fiscal year.

SECTION II. Transfer of Funds Within and Between Appropriations

A. The City Manager, or designee, may approve budget transfers within the same fund to meet operational needs. Department Heads may initiate transfers between non-salary object classifications or programs within their departmental appropriations subject to approval by the Finance Director. Transfers affecting salary and benefit appropriations shall require approval of the City Manager or designee.

B. Transfers between different capital projects shall require approval by the City Council.

SECTION III. Transfers of Funds Between Funds

Transfers between funds identified in the adopted budget, including those reflected in the Schedule of Transfers, are authorized and shall be made as operationally necessary. Any transfer of funds between separate funds not specifically authorized by the adopted budget shall require approval by the City Council.

SECTION IV. Additional Appropriations

The budget may be amended to add, change, or delete appropriations only upon approval by the City Council.
