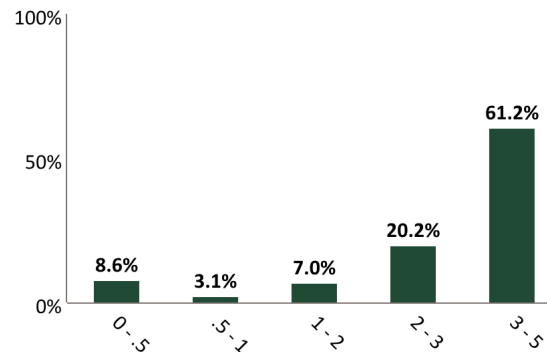

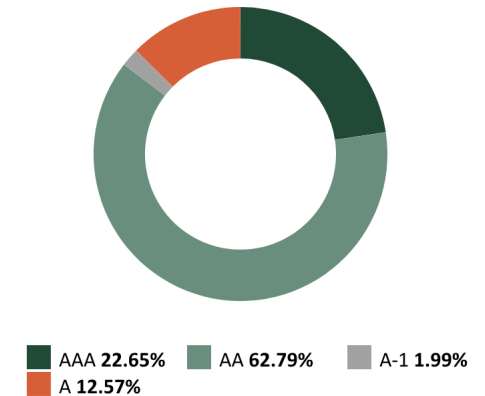
Maturity Distribution
